## IMPORTANT INFORMATION

### VOTING

The Chair will call a poll on each resolution proposed at the Members' meeting held via video conference, in accordance with 5(1)(c) of the Corporations (Coronavirus Economic Response) Determination (No. 3) 2020.

Members who wish to cast a vote in a poll on any resolution at the Meeting may vote via the online platform while attending the Members' meeting.

### APPOINTMENT OF PROXIES

Please note that:

- (a) a Member who is entitled to attend or cast a vote at the Meeting has the right to appoint a person as proxy to attend and vote in the Member's place at the Meeting ("a **Proxy**");
- (b) the Proxy does not need to be a Member or the representative of a Member; and
- (c) a Member who is entitled to cast two or more votes may appoint two Proxies and may specify the proportion or number of votes each Proxy is appointed to exercise.

A form for this purpose is enclosed with this Notice ("**the Appointment of Proxy Form**"). To be valid, the Appointment of Proxy Form (and if applicable, the authority under which the appointment is signed, or a certified copy of the authority), must be received by the Company, by no later than 5.00pm on 27 October 2020 (48 hours prior to the Meeting).
